I understand the total charge to be \$2500 for 2 weeks, \$4250 for 4 weeks, \$6150 for 6 weeks, payable in full by May 1<sup>st</sup>. This includes tuition, laundry, and all activities of instruction. A 10% sibling reduction is allowed for two or more campers attending Camp Country Lad or our sister camp, Camp Monterey.

If registration is canceled before April 1<sup>st</sup>, registration fee will be returned.  
If a camper is withdrawn from Camp at any time, no refund of tuition will be made.

**Acknowledgement of risks**

We, the undersigned parents (or guardians) of the camper named on this application, are aware of the risks which are inherent in the operation of any child's camp and in the child's participation in all camp activities on or off premises of Camp Country Lad LLC including swimming, boating, hiking, tubing, caving, rafting, creek and river hiking, archery, sailing, fishing, horseback riding, wagon or hay rides, athletics, use of tools and equipment in manual arts, arts and crafts, pottery, work projects and other programs, camping out, outdoor living and vehicular travel. I understand that there will be times when my child is not directly supervised, such as walking to and from activities, free periods, playing certain Camp games, and other times during the day. I understand that areas that campers have access to include lakes and rivers, rocky and wooded terrain, rock cliffs, waterfalls and natural hazards such as potentially harmful plants, insects, snakes and other creatures all common to the Cumberland Plateau.

**Release**

In consideration of my child's participation in camp activities, we recognize that the child must abide by all Camp rules and regulations and obey Camp employees. We also acknowledge the inherent risks in Camp activities. We do hereby release Camp Country Lad LLC and the officers, directors, land owners, staff, employees, volunteers of Camp Country Lad LLC from any liability they might incur as a consequence of the failure of the child to obey said employees or to abide by the rules and regulations, and any other liability involving the child's negligence or contributory negligence. I agree that any dispute shall be governed by the laws of the state of Tennessee and shall occur or be filed in Overton County, Tennessee.
